Parenting plans are not legally binding unless turned into a court-approved consent order.

Checklist For Applying For A Domestic Violence Order

Required Documents

- **DV01 Form:** Available online or at the Magistrates Court.
- **Statutory Declaration:** Signed by a Justice of the Peace.
- **Supporting Evidence:** Police reports, medical records, photos.
- **ID Documents:** Personal ID and children's birth certificates (if applicable).

Steps to Apply

1. **Gather Evidence:** Create a timeline of incidents.
2. **Complete DV01 Form:** Fill out online or at court.
3. **Sign Declaration:** Witnessed by a Justice of the Peace.
4. **Attach Documents:** Include all relevant evidence.
5. **Submit Application:** In-person or by post to Magistrates Court.
